### What data do we collect?

### How do we collect your data?

- Enrol on one of our product/service mailing list

Coastline Solutions may also receive your data indirectly from the following sources:

- Other people in your organisation, or one of our partner organisations, who register you to use our products or services, for example your line manager or training manager when assigning one of our training courses to you.

### How will we use your data?

Coastline Solutions collects your data so that we can:

- Register you on a mailing list that you choose to subscribe to

When Coastline Solutions processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

### How do we store your data?

Coastline Solutions will keep your data for the period of time necessary to provide you with our services. Once this time period has expired, we will delete your data.

### **What are your data protection rights?**

**The right to object to processing** – You have the right to object to Coastline Solutions' processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that Coastline Solutions transfer the data that we have collected to another organization, or directly to you, under certain conditions.
